Policy Statement

Our policies are in place to protect adults who may become vulnerable and are at risk of harm and to support all club members.

This policy outlines the club's responsibilities and procedures relating to welfare and safeguarding that are in place to support a safe and happy environment for everyone.

If you are concerned about someone's welfare or protection:

- Don't judge or investigate
- Don't keep it to yourself
- Please refer to the referral flowchart

Reporting a Welfare Concern

Follow these steps if you have a welfare or safeguarding concern regarding an Adult either associated to Royton Road Runners or an individual who has contact with the club

Is the adult in immediate danger or in need of medical attention?



Refer your concern as soon as possible to the Club Welfare Officer

Make a note of anything you witness or have been told.

Document dates and times if possible.

The Club Welfare Officer will contact UK Athletics for further advice if necessary

Get appropriate urgent advice e.g. ambulance/police

Let the operator know that there is an adult safeguarding concern

Responding to a concern

If you have any worries or concerns, please be reassured that the Club Welfare Officer is here to help and will respond to your concern appropriately.

The Club Welfare Officer may contact you to discuss your concern in more detail. This is normal procedure and nothing to worry about.

The club will always attempt to support the individual concerned and can offer advice regarding further help and contacts.

NOTE: It is not the individual or the club's responsibility to investigate a serious safeguarding allegation. The local authority and UK Athletics will provide further support with this.

Roles & Responsibilities

All members of Royton Road Runners have a responsibility to uphold this Welfare Policy and other related policies by adhering to good practice and responding to concerns.

The Club Welfare Officer, Assistant Welfare Officer and Run Leaders are required to hold a current DBS certificate.

The club holds a register of DBS certificates, First Aid qualifications and England Athletics course qualifications.

The Club Welfare Officer will ensure that all their safeguarding training requirements are completed according to UK Athletics guidelines.

Welfare and safeguarding procedure updates will be passed on to club members via email, during club night briefings and at the Annual General Meeting.
